- (3.1) Application #CC23-3, filed by Gleason & Son Signs on behalf of Carol Lee Donuts, requesting the approval of a Certificate of Compatibility to allow the installation of a new wall sign on the front façade of a building located on the southwest corner of South 5th Street and East Iron Avenue. The property that is the subject of this application is the Carol Lee Donut Shop which is located on property legally described as the East 62 ft. of Lot 110 and the East 62 ft. of the North 30 ft. of Lot 112 on Fifth Street in the Original Town (now City) of Salina, Saline County, Kansas and is addressed as 104 North 5th Street. The subject property is legally described as Lots 130, 132, 134, 136 and 138 on Fourth Street in the Original Town (now City) of Salina, Saline County, Kansas and addressed as 138 S. Fourth Street.
