(3.1) Application #V22-7, filed by Justin May on behalf of Jason and Tiffany Wells, requesting a height variance of 1 ft. from 20 ft. (the maximum height allowed for detached garages in the RS [Single-Family Residential Suburban] zoning district), to 21 ft. and a maximum garage size variance of 330 sq. ft. from 1,200 sq. ft. (the maximum detached garage size allowed in the RS [Single-Family Residential Suburban] zoning district), to allow construction of a 1,530 sq. ft. detached garage on their property has been filed for a public hearing before the Salina Board of Zoning Appeals. The subject property is legally described as Lot 3, in the Upper Mill Heights Addition to the City of Salina, Saline County, Kansas and addressed as 440 Upper Mill Heights Drive. (Continued from the June 16, 2022 meeting) (3.2) Application #V22-8, filed by Crosspoint Church, requesting a variance to the restriction limiting fences in the front yard area of a commercial property to Class 3 open fences to allow the installation of a six (6) ft. tall Class 5 solid fence in the front yard setback area along Westport Boulevard. The subject property is legally described as Lots 1 through 7 and Lot 12, Block 1 in the Westport Exchange subdivision to the City of Salina, Saline County, Kansas and addressed as 621 Westport Boulevard.
